How the Program Works

Registration Codes

Hexagon will issue a registration code to the group coordinator of qualified organizations that have enrolled in the Hexagon 2012 Group Registration Program. To receive a group-level discount, registrants must enter their organization's registration code on the online registration form.

Payment

Since the registration code is used to track members of the group, each registrant may pay separately when they check out in the online registration process. If there is a group purchase order (invoice) or check for the entire group, each registrant can simply enter the group purchase order or check number.
